Coops size and distance requirements

- Floor area of 64 sq ft or less.
- Height of 8 linear feet or less.
- Have at least 3 sq ft per bird.
- 10 ft from any property line.
- 25 ft from residential structure on adjacent lots.
- 5 ft from residential structure (house, garage) on applicant lot.
- 2 ft from all lot lines (alley, street)

Manure storage must be:

- At least 25 ft from any residential structure on adjacent lots.
- At least 5 ft from any residential structure on applicant lot.
- At least 2 ft from all lot lines

	Wire netting sufficiently trenched into ground to deter predators from digging underneath		
	Coops and attached structure shall each permit a minimum of 3 square ft per bird (run must be attached)		
	License information is attached to the coop, license holder, license number, emergency contact info		
CONDITIONS FOR KEEPING & SANITATION	Flock size is 6 or less chickens, HENS ONLY, NO ROOSTERS, COCKS, or DRAKES are kept on the property		
	Poultry are kept in coop or attached run/enclosure at all times		
	Poultry have access to feed and clean water at all times		
	Poultry owner is aware disposal process of deceased birds in a safe manner (trash disposal in sealed bag)		
	All waste, including manure is disposed of safely, without creating public nuisance		
	- Composting done in a dedicated container at least 25 ft from residential structure on adjacent lot		
	- Container should be at least 5 ft from a residential structure on the permitted lot		
	- Container should be at least 2 ft from all lot lines (property, alley, street)		
	Licensee is aware of slaughtering procedures & doesn't exceed 5 slaughtered birds per licensing year		
	- Slaughter is done in a humane and sanitary manner outside of public view

Coop cleaned regularly (Free of manure, uneaten feed, feathers, other waste)			
EDUCATION: Discuss handling, specifically mention concerns with unsupervised handling by children			
EDUCATION: Discuss responsibilities if a bird becomes ill or unexplainably dies
